The KZN Department of Human Settlements entails to create a panel of service providers to manage, supply and deliver hardware building material to households affected by April 2022 floods disasters.

A list of beneficiaries will be forwarded to awarded service providers once verification process is completed. The number of affected beneficiaries requiring building material may vary based on the ongoing assessment on the affected areas. The allocation will be made on rotational bases to all service providers that will be appointed on the panel.

### **PRICING TO BE BASED ON:**

Service providers to provide unit cost as per the attached list which forms part of the quotation document. The building material supplied must not exceed R8000.00 per beneficiary. Cost of transportation and management fee must not exceed R1100.00 per beneficiary.

### **SCOPE OF WORKS**

Building material to be supplied per beneficiary must be based on the building material list which forms the part of quotation document.

Appointed service providers must not supply building material specified on the attached list without prior written approval from the Department.

Appointed service providers must ensure that material provided meets the required SABS standards.

Appointed service providers must ensure the following:

- Affected beneficiaries are on the beneficiary list from the KZN Department of Human Settlements.
- Ensure that beneficiaries sign a proof of delivery/receipt.
- Appointed service providers must ensure that they provide the KZN Department of Human Settlements with monthly progress reports on the progress of the program and sensitizing on the areas of concern.

### **80/20 PREFERENCE POINTS SYSTEM**

The 80/20 Preference Points System will be utilized. In terms of Regulation 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:
