Phase 4 of the Expanded Public Works Programme (EPWP) will be launched over the next few weeks. The national target is 5.6 million work opportunities.

In Phase 3, KwaZulu-Natal delivered more than 750 000 work opportunities and was the top performing province in the country.

### Title deed roll-out brings home ownership to thousands

As part of the KZN Department of Human Settlement's push towards the promotion of home ownership, MEC Ravi Pillay and officials from the department have travelled the length and breadth of the province to issue title deeds to qualifying beneficiaries. About 18 000 title deeds have been delivered in the past five years.

In the coming three months, 16 227 more title deeds, which are already in the possession of municipalities, will be handed out. A team of officials is currently visiting all the identified housing units to complete the verification questionnaires and compile a schedule of title deeds to be handed over to their rightful owners.
