Tt is nearly over... like waiting for the dawn... Cornhill and Colley Street residents are expected to finally have the title deeds to their state owned homes by the end of next week...

Human Settlements MEC, Ravi Pillay, has promised Dawn de Beer that he will come himself to hand out the last title deeds - ending a battle against red tape and inefficiency first launched by Dawn in April 2004.

While Dawn fought for title deeds to be given to all who have for years rented State owned houses in Dundee and Glencoe, ironically she is one of the

last to receive her ownership papers. In April 2011, 104 residents of Peacevale and Forestdale were given the deeds to their homes in an elaborate public ceremony hosted by then MEC for Human Settlements, Ms Maggie Govender.

Sadly, others were left wondering when they would be receiving their deeds; Dawn being one of them. Ms Govender did, however, promise that her office would make more deeds available in November that year.

The excitement building up to November was cut short in October when Ms Govender and her entire team were removed from their posts.

Once again there was no light at the end of the
